## PUBLIC CONSULTATIONS ON THE I.D.B.'S DRAFT ENVIRONMENTAL AND SOCIAL POLICY FRAMEWORK



The Indian Law Resource Center is a non-profit law and advocacy organizations established and directed by American Indians. The Center provides legal assistance without charge to Indian and Alaska Native Nations and other Indigenous communities in the Americas that are working to protect their lands, resources, human rights, environment, and cultural heritage. Our principle goal is the preservation and well-being of Indian and other Native Nations and tribes.

The Inter-American Development Bank (I.D.B.) has officially begun the review of its socio-environmental policies, including its OP-765 Operational Policy on Indigenous Peoples of 2006. The result of this revision process will be a new Environmental and Social Policy Framework that will contain several socio-environmental policies in a single policy framework. The safeguard measures contained in these policies are critical to prevent projects financed by the I.D.B. from adversely affecting indigenous peoples and other local communities, as well as the environment on which they depend upon for their survival.

### What has happened in the modernization process so far?

On July 2, 2019, the I.D.B.'s Board of Executive Directors approved the [Policy Profile](#), the document that governs the review process and indicates which policies are subject to review, as well as the plans on how the review process ought to be carried out.

On August 8, 2019, the I.D.B. held a meeting in Washington, D.C. in order to discuss the review process and the necessary safeguard measures to prevent adverse impacts to indigenous peoples and their environment. Within the framework of this meeting, some representatives of indigenous organizations participated and demanded that the I.D.B. carry out a significant consultation process dedicated to gathering inputs from representatives of indigenous peoples and organizations in the region.

On December 18, 2019, the I.D.B. Board of Directors approved a draft of the Environmental and Social Policy Framework (Draft Policy). It is now available in the four official languages of the I.D.B. ([English](#), [Spanish](#), [French](#), and [Portuguese](#)). In particular, the Environmental and Social Performance Standard No. 7 Indigenous Peoples of the Draft Policy specifically establishes safeguard measures aimed at preventing projects financed by the I.D.B. from adversely impacting indigenous peoples and communities in the region.

### When do in-person consultations begin in the region?

As of February 2020, the I.D.B. will begin holding two-day, in-person consultations in Panama, Jamaica, Peru, Argentina, and the United States. The proposed agenda that will serve as the basis for such consultations is available [here](#). The dates of such consultations are as follows:

We were informed that the second day of each of these consultations will be dedicated to receiving inputs from the indigenous peoples and organizations of the corresponding regions. For example, the consultation on February 19, 2020, in Panama will be dedicated to the indigenous peoples and organizations of Mexico and Central America; the consultation on February 28, 2020, in Jamaica will be dedicated to the indigenous peoples and organizations of the Caribbean; the consultation on March 4, 2020, in Peru will be dedicated to the indigenous peoples and organizations of the Andean countries; and the consultation on March 10, 2020, in Argentina will be dedicated to the indigenous peoples and organizations of the Southern Cone. We were also informed that interpretation services in Quechua will be provided for the consultation in Peru on March 4, 2020.

The Indian Law Resource Center, in conjunction with the Interethnic Association for the Development of the Peruvian Amazon (AIDSESP), will hold a preparatory workshop for indigenous peoples and organizations on March 3, 2020, at AIDSESP's office, located at Av.
